AGREEMENT

This Intracytoplasmic Sperm Injection (ICSI) Services Agreement ("Agreement") is entered into by and between Genetech UK ("Genetech") and the individual identified above ("Client").

Genetech shall provide intracytoplasmic sperm injection, in vitro embryo production, freezing, storage, and shipment of any resultant embryos ("Services"), in accordance with the fee schedule. Deliverables include transferrable fertilised embryos (e.g., mature blastocysts). Additional services may only be performed by written agreement.

The Client agrees to:

- Arrange oocyte recovery from their donor mare and shipment to Genetech.
- Ensure timely delivery of semen and oocytes.
- Bear full responsibility for all transportation costs, courier charges, and any associated insurance.
- Provide accurate information and promptly notify Genetech of any changes.
- Ensure compliance with relevant breed registry requirements.

Genetech shall:

- Evaluate, mature, and, if appropriate, fertilise oocytes via ICSI.
- Perform services as agreed and as outlined in the fee schedule.
- Store frozen embryos for an annual fee, taking reasonable precautions but accepting no liability for loss or damage.

Client acknowledges:

Genetech provides no guarantee of success.

- Risks include oocyte failure, embryo loss, incorrect parentage, or failed pregnancy.
- Genetech is not liable for any third-party services or handling, including transport or diagnostics.

Liability: Genetech's liability is limited to the amount paid for the service. In case of willful negligence only, compensation is limited to the cost of:

- £15 per straw of lost or damaged semen.
- The fee charged by Genetech for each embryo lost or incorrectly produced.

Termination:

- Genetech may terminate the agreement at any time with 10 days' notice or immediately for breach.
- Client remains responsible for payment of services rendered up to the date of termination.
